ORDER LIFTING THE STAY OF CIVIL MATTERS INVOLVING THE COMMISSIONER OF SOCIAL SECURITY AS A PARTY UNDER 42 U.S.C. § 405(g)

ORDER OF THE CHIEF JUDGE 21-037

(Supersedes Order of the Chief Judge 20-074)

WHEREAS on April 17, 2020, due to the impact of the COVID-19 pandemic on the Social Security Administration's ability to prepare certified administrative records ("CARs"), the following actions were stayed by Order of the Chief Judge 20-074: (a) actions brought against the Commissioner of Social Security pursuant to 42 U.S.C. § 405(g) that were filed on or after April 17, 2020; and (b) those previously-filed actions in which the Commissioner had not prepared and served the plaintiff with the CAR:

WHEREAS since issuing Order of the Chief Judge 20-074, the circumstances concerning the COVID-19 pandemic have improved and the Social Security Administration has resumed preparing CARs; and

WHEREAS although its operations have resumed, the Social Security Administration requires additional time to prepare CARs in certain cases given the backlog resulting from the prior limitations on its operations due to the COVID-19 pandemic;

THEREFORE, for good cause shown, the Chief Judge orders as follows:

- 1. The stay imposed in Order of the Chief Judge 20-074 is hereby lifted.
- For actions brought against the Commissioner pursuant to 42 U.S.C.
 § 405(g) that were filed in 2020, any outstanding CARs must be produced within 90 days of the date of this Order.
- 3. For actions brought against the Commissioner pursuant to 42 U.S.C. § 405(g) that were filed in 2021 before the issuance of this Order, any outstanding CARs must be produced within 120 days of the date of this Order.
- 4. The assigned Judge retains discretion to alter the time frames provided in this Order in individual actions.
- 5. Actions brought against the Commissioner pursuant to 42 U.S.C. § 405(g) that are filed after the date of this Order are subject to the procedures in the assigned Judge's case management order.

IT IS SO ORDERED.
