1 Plaintiff LA Alliance for Human Rights, Defendant City of Los Angeles, and
2 Intervenorors (“the Parties”) have met and conferred regarding the Order to Show Cause
3 re: Contempt currently scheduled in this matter on Wednesday, November 19, 2025.

4 The Parties are hopeful that the presentation of evidence may be completed in
5 one day. However, the City does not believe that one day will be sufficient, and all the
6 Parties acknowledge that it may require more than one day.

7 Intervenor CANGRESS has a trial on Thursday, November 20, 2025 in a writ
8 proceeding in Los Angeles Superior Court (CANGRESS v. City of Los Angeles, LA
9 Sup. Ct., Case No. 25STCP00261). Lead counsel for Intervenorors in this matter also
10 represents CANGRESS in the writ proceeding.

11 The Parties have met and conferred regarding the potential scheduling conflict,
12 assuming the OSC goes beyond the first day. In the event the hearing is not completed
13 on November 19, 2025, the Parties jointly request the Court reconvene the hearing on
14 Friday, November 21, 2025 or thereafter, consistent with the Court’s availability, to
15 accommodate Intervenor’s conflict on Thursday, November 20, 2025.

16 In the alternative, the Parties propose moving the hearing from Wednesday,
17 November 19, 2025 to Friday, November 21, 2025 and if necessary, the hearing can
18 continue without interruption on Monday, November 24, 2025.

19 The Parties also jointly request that no hearing days take place on Thursday,
20 November 27 (Thanksgiving Day) or the following day.
