Action Filed: March 10, 2020

1 Defendant City of Los Angeles, Plaintiff LA Alliance for Human Rights, and
2 Intervenors Los Angeles Community Action Network and LA Catholic Worker, by and
3 through their respective counsel of record, provide the following joint status report in
4 accordance with the Court’s instruction at the April 23, 2026 hearing, Dkt. 1230.

5 Following the April 23 hearing, the parties have continued their good-faith
6 mediation efforts before the Honorable Andre Birotte and have reached an agreement
7 on all pending issues except for one. The Parties are continuing to discuss the final issue,
8 with assistance from Judge Birotte, in an effort to reach full resolution. All agreements
9 are subject to approval by the City Council.

10 The matter has been agendized for the May 5, 2026 City Council meeting. The
11 parties will provide the Court with an update following the City Council’s consideration
12 of the Parties’ agreement.

13 Given these developments, the City requests that the Court vacate or continue the
14 hearing scheduled for May 8, 2026.
