

Weighted Filings per Judgeship



The number of weighted filings per judgeship for the Central District of California rose significantly to 627 for fiscal year² ("FY") 2018, an increase of 10 percent from 570 a year ago. The national average was 513 weighted filings per judgeship. The Central District of California ranked 14th in the nation and 4th in the Ninth Circuit for weighted filings in FY2018.

¹ Case weights are based on the district court case weighting system approved by the Judicial Conference of the United States at its March 2016 session.

² The fiscal year is the 12-month period ending September 30.

The Central District of California has 28 authorized Article III judgeships. At the end of FY2018 the Central District had six vacancies, double from FY2016. The oldest vacancy is from August 1, 2014. In 2015, the Court experienced its second. In 2016 through 2018, two additional vacancies arose each year. At the end of FY2018 the number of vacant judgeship months was the highest it has been in the Court's history. Vacant judgeship months are the total number of months that vacancies occurred in any judgeship position in a circuit or district.



In FY2018, the Central District of California saw an 8.6 percent increase in combined civil and criminal case filings from FY2017. Total case terminations decreased 2.4 percent and total pending cases increased 13.1 percent from FY2017. During the five-year period ending September 30, 2018, total civil and criminal case filings increased by 7.2 percent; total terminations declined by 4.3 percent; and total pending cases rose 11.4 percent.


A total of 15,335 civil cases were filed in FY2018, an increase of 7.4 percent from 14,275 in FY2017. Terminations dropped 3.4 percent and pending civil cases increased 13.5 percent from FY2017. During the five-year period ending September 30, 2018, civil case filings increased 5.3 percent, representing a five-year high; terminations dropped 5 percent; and pending civil cases rose 9.7 percent to 11,001.





Between FY2014 and FY2018, the total number of criminal case filings surged 42.2 percent and criminal defendant filings rose 28.9 percent, a five-year high. In FY2018, criminal case filings in the District increased 26.2 percent and filings for criminal defendants increased 26.8 percent from FY2017. In FY2018, criminal case terminations in the Central District of California increased 14.6 percent; terminations for criminal defendants increased 8.1 percent; pending criminal cases increased 11.2 percent; and pending criminal defendants increased 12.3 percent from FY2017.






Civil Case Filings



Civil rights case filings constituted the highest percentage of all civil case filing categories at 26 percent in FY2018. There were more contract, tort, (other than personal injury/product liability) and civil rights cases filed in FY2018; however, there were fewer all other civil, real property, personal injury/product liability, and social security cases filed compared to FY2017. In FY2018, contract case filings increased 68.1 percent.






Civil Removal Filings



A total of 4,179 civil removal cases were filed in FY2018, an increase of 20 percent from FY2017. Civil removal filings represented 27.3 percent of the total filings in the Central District of California: 73 percent of the removals were filed in the Western Division; 12 percent were filed in the Southern Division; and 15 percent were filed in the Eastern Division. The largest percentage of civil removal filings were contract (36 percent) and civil rights (19 percent) cases.



Non-Prisoner Pro Se Filings




12 percent of the 15,335 total civil cases filed in FY2018 were non-prisoner cases with at least one pro se party.³ Of these, 62 percent were real property and civil rights cases.


Criminal Defendant Filings



In FY2018, criminal defendant filings increased 26.8 percent from FY2017. The top three major offense categories for criminal defendant filings in FY2018 were drug offenses (33 percent), property offenses (28 percent), and immigration offenses (11 percent). The number of defendants charged with drug offenses increased by 17.5 percent, the number of defendants charged with property offenses increased by 17.4 percent, and the number of defendants charged with immigration offenses increased by 94.9 percent from FY2017.





Civil Case Filings Referred to Magistrate Judges for Report and Recommendation




In FY2018, 18.4 percent of the total civil filings were referred to Magistrate Judges for report and recommendations. Of the cases referred for report and recommendations, 34 percent were habeas corpus petitions, 34 percent were Social Security appeal cases, 24 percent were prisoner civil rights cases, 8 percent were non-prisoner pro se civil rights cases, and 1 percent were other cases referred for report and recommendations.




Consents to Magistrate Judges

Parties consented to proceed before Magistrate Judges in a total of 1001 cases in calendar year 2018, a 6.4 percent decrease from 2017. Of this total, all parties consented in 871 cases that were referred to a Magistrate Judge for a report and recommendation; all parties consented in 45 cases assigned to Magistrate Judges through the Direct Assignment of Civil Cases to Magistrate Judges Program; and all parties consented to proceed before Magistrate Judges in 73 cases through the Voluntary Consent List of Civil Cases to Magistrate Judges Program.

In calendar year 2018, Magistrate Judges held 363 settlement conferences in 321 cases. Of these, the Magistrate Judges settled 141 cases, for a 44 percent settlement rate. The Magistrate Judges spent a total of 2120.15 hours, equivalent to 265 days, working on settling these cases.



In calendar year 2018, six District Judges participated in the Patent Pilot Program in the Central District of California. In 2018, the Judges designated to receive patent cases under the Patent Pilot Program received 174 patent cases, of which 65 were initially assigned to them, 60 cases were transferred to the program from non-participating Judges, and 49 cases were transferred to the program as a result of related case transfers or other reasons. The number of patent cases filed in calendar year 2018 decreased by 3 percent and the number of cases transferred to the program by non-participating Judges decreased by 12 percent from 2017. In 2018, the percentage of patent cases filed that were assigned or transferred to Judges participating in the Patent Pilot Program was 61 percent. Since the program started in September of 2011, a total of 1,482 patent cases have been included in the program.






In calendar year 2018, there were a total of 224 trials held before all Judges in the Central District of California, a 9 percent increase from 2017. In 2018 of the 224 trials held, 72 percent were jury trials and 28 percent were bench trials. From 2017 to 2018, civil jury trials increased 19 percent; civil bench trials dropped 24 percent; criminal jury trials increased 15 percent and criminal bench trials rose 89 percent. During the three-year period ending December 31, 2018, trials increased 7 percent overall.







In calendar year 2018, there were a total of 19,629 jurors in attendance for the Central District of California, a 0.1 percent increase from 2017. Over the five-year period ending December 31, 2018, the number of jurors in attendance decreased 7 percent from 21,109 in 2014.

In calendar year 2018, the Central District of California naturalized 76,920 citizens, a 16 percent decrease from 91,435 in 2017. Over the five-year period ending December 31, 2018, the Central District of California naturalized just under 400,000 citizens.
